1) Welcome note, members, Sportaccord application (Marcel Weigl)

FIR president Marcel Weigl welcomes all representatives and gives the word to Fairplayce Sportscentre owner Ryszard Flisikovski, who apologizes in a long talk for the move of the FIR World Championships Doubles and Teams from Poznan to Wroclaw due to missing fire emergency permits in the newly built Fairplayce Sports centre. He also confirms that all transport and hotel re-booking measures are taken that none of the players should have any additional costs if they have handed in the claims until the deadline before the beginning of the tournament.

Marcel then reports further:

Existing members must do homework and register sole national Racketlon federations, create simple websites, get official answers from NSA – National Sports Associations or NOC – National Olympic Comittees after Sportaccord membership rejected

- Sportaccord president Marius L. Vizer has kept his promise and returned 3500 Euro Sportaccord application fee
- With Ghana FIR has a new member thanks to charity cooperation of RFA Racketlon Federation Austria and Dekpor highschool initiated by Cornelia Schmickl. RFA has also sent over Badminton and tennis rackets for the children to get started
- Malta under the head of Duncan Stahl has been awarded a World Tour event 2015 with the obligation to form the national federation until then

3) Report of the Council 2014 (Marcel Weigl)

- Tournament Software replaces Resultreporter
- FIR-Delegates and Co-Delegates at all World Tour events
- Published Racketlon magazine together with World Champs in England

4) Financial Report 2013, 2014 (Lennart Eklundh)

- ➤ Lennart reports that the final result for 2013 presented at the EGM 2014, a minus of 2185 Euro, has now been confirmed and signed by the auditors Hakan Granberg and Stefan Adamsson and is attached to these minutes
- Summarizing all results since 2002, FIR started the year 2014 with minus of 165 Euro
- The forecast for 2014 is increased to a minus of 3203 Euro (originally 1750 € pred. result)
- ➤ The 2014 result included start-up costs of Tournament Software with 6655 Euro

5) Members Report 2014

Due to the lack of time at the World Champs members there is no members report by FIR members. On request only Germany's president Deck brought up an issue, if FIR can please E-mail the three possibilities and costs of "national Tournament Software" use to all members.



6) Council Elections (Jason Granville)

Marcel thanks resigning Council members Karim Hanna (Sui), Nathalie Zeoli (Ger) and Dany Lessard (Can) for their work for FIR in the past years. Then Marcel states that although the team stands for elections for a period of three years from 2015 to 2017 according to FIR statutes, Lennart, Graham, himself and maybe others will re-consider an early re-assignment in one year's time already, depending on possible financing and changing structures in FIR.

7) Council Preview 2015 (Marcel Weigl)

A short list of the main FIR wants to achieve 2015:

- Optimize Tournament Software
- Assignment Agreements with national federations holding World Tour events in their countries especially in concern to all fees, liabilities and fines
- ➤ Get all FIR members to do their homework and present papers to Sportaccord
- ➤ Re-Structure FIR with at least 1,5 fix employees through EU projects
- Alternative ways of financing: "World Tour sponsor lottery"
- 1st European University Championships in Szombathely/Hungary (16.-18.6)
- 1st ever European Championships end of November
- Other Continental Championships such as Oceanic Australia/New Zealand
- New World Tour events Turkey (1.-3.4.) and Malta (2.-4.10)
- Livestream project started at Austrian Open with Mediahouse 24
- News if FIR will receive an EU project is expected for December 2014

8) Finances Preview 2015 (Lennart Eklundh)

- ➤ Lennart presents the budget for 2015 assuming the same FIR structure as in 2014 and no EU-Project obtained with a plus of 2910 Euro
- > This should even the loss of 2014 and FIR should be even in results at the end of 2015

9) Request by FIR Council and FIR members

FIR Council has requested the AGM to exclude Mongolia and Pakistan from FIR, as there has been no contact and no membership payment for the last two years

This is accepted by FIR AGM unanimously, Pakistan and Mongolia excluded from 1.1.2015!



10) Any other Business (Marcel Weigl)

- Marcel informs the AGM that after informing the EGM in Surrey he has now accepted the offer of owning 1/4th of the trademark Racketlon by current owners Hans Mullama, Peter Landberg and Lennart for the benefit of international Racketlon. The four now own 25% each.
- Marcel informs that the Court of Arbitration has been called by Keith Lesser concerning fees for the Single World Champs 2014. The court with the majority votes of Volker Sach and Zoltan Albert has ruled that the FIR payment specification is to be corrected by deducting fees for non-entry-fee-paying council members and then to be paid immediately.
- Phil Reid will be replaced in the Court of Arbritation on his own wish. FIR has nominated former Council member Dany Lessard, who has accepted this position.
